IMPLEMENTATION STATUS OF GO.Ms.No: 1/2003 FOR TRAFFICKING SURVIVORS

Background

In 2003, the State Government of Andhra Pradesh introduced the GO.Ms. No: 1/2003 & 28 Reg. (hereafter, 'GO'), a policy for combating the trafficking of women and children for commercial sexual exploitation. The policy contained detailed provisions to set up infrastructure at the state and district level to counter trafficking, as well as measures to prevent trafficking, rescue victims and rehabilitate, support and provide them relief.

The GO was welcomed by anti-trafficking stakeholders such as Vimukthi Survivor Leaders' Collective, who pointed out the link between improved rehabilitation services and reduced second-generation trafficking, as well as reduced instances of rescued survivors being re-trafficked and re-victimised. Even though the GO did not contain explicit provisions on prosecution and conviction of traffickers, there is a clear link between the levels of State support provided to survivors and strength of witness and complainant testimony in court cases. Therefore, support, rehabilitation or relief to survivors could positively impact legal case outcomes, leading to greater conviction rates of traffickers.

RTI Study on Implementation of GO (2015-2020)

On 7 November 2021, **VIMUKTHI** Survivor Leaders' Collective sent an RTI to the Director of Women Development and Child Welfare, Government of Andhra Pradesh, seeking information regarding the implementation status of the GO, from January 2015 till August 2020. On 20 April 2022, the Joint Director of the Women Development and Child Welfare Department responded to **VIMUKTHI**'s RTI, claiming that the GO was implemented in Andhra Pradesh. **However, the RTI response failed to answer several questions, for seemingly no reason – and even the questions that were answered bore several contradictions to the actual ground level situation in the state, calling into question the veracity and accuracy of the information provided.**

State and District Coordination Committees failing to perform obligations

Firstly, the State Government failed to respond entirely on whether the State Level Coordination Committee had held meetings between 2015 and 2020.

Data on District Committees showed highly varying numbers of meetings across the state.

 Srikakulam, Kadapa, Ananthapur, Nellore and Vizianagaram did not conduct even a single meeting between 2015 and 2020.

- Vishakhapatnam conducted 2 meetings, but did not result in even a single victim benefitting between 2015 and 2020.
- In Prakasam district, the RTI response claimed that there were 8 district level meetings from 2015-2020 that discussed "strengthening of community vigilent groups conducting awareness camps to women and girl children in vulnerable areas" that benefitted 26 victims.

Considering that the State Coordination Committee is the state-level nodal body responsible for monitoring the overall trafficking situation and implementing schemes for survivors, it is alarming that not a single scrap of information exists on any of their meetings, if they were even held. Further, the data on District Committee meetings is called into question, as **HELP** organisation is a member of the Prakasam district committee, and knows that not a single district-level meeting has taken place from 2015 onwards. Therefore, the State Government has wantonly provided unsubstantiated information that contradicts the actual ground-level situation.

Efforts to Prevent Trafficking

Efforts to prevent trafficking in Andhra Pradesh include high levels of awareness campaigns against trafficking, with a few cases showing other measures being taken.

• To address the first root cause of trafficking –poverty, only Prakasam district undertook economic empowerment of 26 survivors of trafficking between 2015 and 2020. No other district undertook any such efforts.

Despite the GO mandate to further literacy, the Government failed to adequately address its obligations.

- The Government did not provide children of trafficked survivors with residential transit schools to prevent second-generation trafficking.
- Zero child survivors of trafficking received scholarships in Andhra Pradesh.
- Only 6 children received tuition services to prevent school dropouts.
- Only 2 victims were declared as orphans and provided benefits from 2015 to 2020.

Data on prevention of trafficking in Andhra Pradesh shows that most efforts are aimed at awareness building, with the State Government doing little else to actually address trafficking's root causes. Poverty alleviation and child welfare programmes are conducted in highly rare cases.

Rescue of Trafficking Victims and Effective Prosecution of Trafficking Cases

As per NCRB reports, from 2016 to 2020, nearly **1,669** victims of trafficking were rescued under provisions of the Indian Penal Code, 1860 (IPC), and **550** victims (a total of **2219**) were rescued under the Immoral Traffic (Prevention) Act, 1955 in the state of Andhra Pradesh.

• Anti-Trafficking Squads in Krishna, Guntur, Nellore Kadapa, Kurnool and Ananthapur did not rescue even a single victim of trafficking between 2015 and 2020.

The law makes provisions for confiscating the assets of exploiters and compensating survivors in court, as well.

- There were zero cases in Andhra Pradesh courts that utilised these provisions for the benefit of trafficking survivors.
- Traffickers were never fined for committing crimes.
- Out of all the districts, only Prakasam district claimed that trafficking cases were efficiently prosecuted and summarily disposed before courts.

There is a huge disparity between the number of victims rescued, and the distribution of rescued victims in the State, with several Anti-Trafficking Squads seeming to be inactive in nature. Further, although the law allows for prosecutors to seek confiscation data from district courts show that the provisions are rarely, if ever used.

Rehabilitation, Relief and Support Services

District Committees are obligated to ensure rehabilitation, immediate relief and support services for rescued survivors.

- 60% of rescued survivors have still not received immediate relief and support.
- Only Krishna district provided pacca houses to survivors of trafficking.
- Legal services were made available to very few victims only in Guntur, Prakasam and Vishakapatnam through local NGOs who are running shelter homes.
- Medical services were highly sparse as well, with health cards being provided to victims in Prakasam district only.
- Free medical services were available to victims only in Kurnool, Krishna and Prakasam districts.
- HIV positive victims of trafficking also received care only in Guntur and Prakasam districts.
- Vimukthi found that in addition to the above failures of the State Government, Government
 duty bearers were incorrectly issuing meagre sums of INR 20,000/- under GO.Ms.No:28 to the
 rescued victims, which should be provided as immediate relief, as entire rehabilitation
 amounts.

Therefore, despite a high number of trafficking victims being rescued in the **state of Andhra Pradesh** between 2015 and 2020, only a small percentage of these survivors, if at all, receive rehabilitation, immediate relief and support services. Most survivors also receive highly insufficient compensation and the majority of districts of Andhra Pradesh have undertaken almost no actions to substantively rehabilitate and support survivors of trafficking, whether adults or children.

GO Ms. 1/2003: A Failed Promise:

A review of the GO.Ms.No:1 & GO.Ms.No:28 implementation status, therefore, shows that firstly, there is no accountability by **District** nor **State Committees**, as well as clear neglect on the part of the **Department of Women Development and Child Welfare** in undertaking their obligations under the GO. There is poor implementation of rehabilitation services for survivors as mandated under the GO, and no compensation of survivors by court orders. Further, although the GO contains lofty provisions

on prevention of trafficking, there is little to no implementation of such initiatives in most districts of the state. As a result, human trafficking continues unabated in Andhra Pradesh, as evidenced by NCRB data that shows high prevalence of trafficking, but low conviction rates.

The GO.Ms.No:1 contains comprehensive provisions to prevent trafficking, as well as a list of services to which child and adult trafficking survivors are entitled, spanning foster care, education, healthcare, civic amenities and legal reform services. Proper rehabilitation and support services can prevent generational trafficking, and the failure of the State Government to provide any to survivors of trafficking results in even rescued victims being re-trafficked and re-victimised.

Further, even though the GO.Ms.No:1 does not contain explicit provisions for prosecution and improving conviction rates of traffickers, the lack of support, rehabilitation and immediate relief services for survivors can weaken their positions in courts, resulting in acquittals of traffickers in legal cases. Hence, there is a strong link between such welfare services and levels of conviction as well. The information provided by the State Government shows that there are no substantive support schemes for survivors, which in turn gravely impacts their chances in court against exploiters and traffickers. Survivor leaders from Vimukthi consider such a failure nothing short of a "broken promise" by the State Government, which had enacted the policy directive for their welfare but fail to act upon it, even two decades later.

Recommendations:

We suggest following ways to address this crisis in Andhra Pradesh and we hope the Andhra Pradesh Government will entertain our suggestions:

The State Government shall take all the necessary measures for strict implementation of all the provisions under this **G.O.Ms.No. 1/2003** for economic empowerment of rescued women and victims of Commercial Sexual Exploitation.

- 1. Immediately pay attention on strict implantation of GO.MS. No. 1/2003
- There is a need to look beyond this *institutional care model*, and supplement this approach with a
 Community-Based Rehabilitation (CBR) model, a survivor-led approach that has been demonstrated to
 allow for better reintegration outcomes for survivors while also allowing them to break the cycle of
 poverty.
- 3. **SHGs** to be promoted with survivors of trafficking and Sex workers through **Community Based Rehabilitation Policy** for enhancing opportunities for their economic empowerment. Micro credit facility to be facilitated to them.
- 4. Livelihoods with Financial support to be provided for the **SHGs** formed with Survivors of Human Trafficking and Sex workers through **MEPMA** and **DRDA**, as per the recent directions by the **Supreme Court of India**.
- 5. **Alternative Livelihoods through SHGs and Cooperatives-** The Andhra Pradesh Government should work to break the chain of debt bondage by providing alternative livelihood plans that offer identity (Government-authorized personal ID proofs) and financial security (opening bank accounts, taking loans for starting new ventures and starting savings for future.
- 6. **Directives on Facilitation of SHGs of sex-workers** --There are registered CBOs of SACS but not all sex workers are registered in the CBOs, so there has to be a mechanism to include all the women in sex work.

- 7. There shall be subsidy loan facilities through GO.Ms.No:1/2003 to the survivors of trafficking and sex workers for their self employment under *women Finance Corporation* and *SC/ST/BC finance corporations*.
- 8. Trainings to be imparted for their livelihoods. Training cum production centres to be established for them along with facilitating employment opportunities.
- 9. There shall be 50% reservation for employment of the rescued victims among the NGOs who are running the programmes with the support and funds by the Government.
- 10. There shall be housing or house sites for the rescued victims & victims of Commercial Sexual Exploitation under *special category* through GO.Ms.No:1/2003.
- 11. Rescued survivors of trafficking have been allocated with Rs20,000/- as **Immediate relief support** under **Go.Ms.No.28**. this support shall be mandated to provide support to the rescued survivors within the one week after their rescue.
- 12. Ensure victim, and witnesses protection services for improved convictions
- 13. Case wise follow up should be ensured for relief, rehabilitation and reintegration
- 14. All the entitlements for the general public should be accessible by the trafficked victims.
- 15. As a preventive measure, youth organisations, local bodies within communities and schools must be involved and sensitized on the role of gender in daily life, education and knowledge about sex and reproduction, and prevention of exploitation.

Recommendations for primary and secondary stakeholders:

- Rehabilitation has to cover psychological, economic, physical, as well as socio-cultural well-being
- Special courts, special judges, priority hearing, fast-track redressal, summary trials are some of the
 measures that can expedite justice and remove obstructions in the way of social reintegration for the
 survivors.
- Maintenance grant should be given to women in traditional prostitution and their children supported with free educational material.
 - 1. Boarding Schools for children or women victims
 - 2. Income generation and economic rehabilitation
 - 3. Public awareness through information, education & publicity.
 - 4. Free Health check-ups and treatment.
 - 5. Institutional care for children, providing night shelter, Balwadi, educational support programme, women's empowerment programmes in the red light areas could be some of the alternatives.
- Girls/women could be involved in pre-employment and employment programs, where they could work on hourly basis in the office or as part of outreach for skill building.
- Roles of NGOs must be recognised and involved to make a lasting difference.
- Emphasis must be laid on prevention education, outreach to at-risk populations, teachers and school counsellors, health and human services professionals, juvenile justice and child welfare systems personnel, parents, and communities at large.
- All the entitlements for the general public should be accessible by the trafficked victims.
- Vocational skills and job placements must be ensured.
- As a preventive measure, youth organisations, local bodies within communities and schools must be involved and sensitized on the role of gender in daily life, education and knowledge about sex and reproduction, and prevention of exploitation.
